

## Wise and Silent: Conditions of Entry:

By entering the The Wise and Silent Travel Giveaway you are agreeing to the following Terms and Conditions.

#### 1. Conditions:

- 1.1 Information on how to enter and prizes form part of these Conditions of Entry. Entry into this promotion is deemed acceptance of these Conditions of Entry.
- 1.2 The Promoter is Wise and Silent, ('Promoter')
- 1.3 This competition is governed by the laws of NSW.

# 2. Eligibility

- 2.1 Entry is open to Australian Permanent Residents who have signed up to Wise and Silent database and are 18 years or over to enter.
- 2.2 Employees and immediate family members of the Promoter and suppliers, providers and agencies associated with the promotion are ineligible to enter.
